TERMS AND CONDITIONS PURCHASE OF BULLTERRIER PUPPY SELLER: RION BULLTERRIERS BUYER: APPLICANT BUYER

 Buyer shall have puppy examined by locally licensed veterinarian within seventy-two (72) hours of receiving the Puppy from Seller. (Failure to have the Puppy examined by veterinarian voids the remainder of this paragraph of the contract.) If a health problem is identified within the first seventy two (72) hours after delivery was taken, as determined by said veterinarian, the Buyer shall notify the Seller immediately upon consultation with said veterinarian, depending on the identified health problem the seller shall authorize the return of the puppy to be re-examined by Sellers veterinarian, the seller shall take possession of the puppy and replace it with an available puppy from this litter or a future litter.
The Seller will provide Buyer with a booking confirmation once puppy has been paid for, the seller bares the right to keep the puppy until it has been deemed fit to be self-sufficient and strong enough to be rehomed, the projected dates and time for puppy to rehome might change as development of puppy advances.

The puppy was examined by Seller and is in their opinion to be clear of any health defects. Any and all types of cancer, arthritis, cataracts, deafness, hearth defect and any health defects that can be accumulated whilst ageing, to be excluded from health guarantee under this contract, since these would be considered to be expected aging process in many dogs.
The Buyer is Responsible for all vaccinations after delivery is taken. The puppy will have received a series of vaccinations up and to the date of delivery. It is the buyer's responsibility to complete the rest of the vaccinations as recommended by breeder or veterinarian.

5) The puppy would have been permanently identified by insertion of microchip underneath the skin. The buyer will be responsible for the update of the chip details

6) The Buyer agrees that the puppy will be kept and maintained at the home of the Buyer, with proper feeding, care, shelter and fenced area. The buyer further agrees not to allow the puppy to roam free or become a public nuisance.

7) The buyer understands that the puppy's temperament is solely the responsibility of the buyer. The puppy must be properly socialized and trained, failure to do so may result in an aggressive adult dog. Puppy classes, basic obedience and discipline are highly recommended

8) The erection of the puppy's ears is the sole responsibility of the Buyer. The seller cannot ensure that the puppy's ears will become fully erect on its own and therefore it is the Buyers responsibility to ensure erection of said Puppy's ears.9) The buyer is not at any time permitted to re sell or give away said puppy. If buyer is no longer capable of taking care of the

9) The buyer is not at any time permitted to re sell or give away said puppy. If buyer is no longer capable of taking care of the puppy, he/she shall notify the Seller so that the puppy shall be returned to the seller at the buyer's expense.
10) The puppy shall under no circumstances be abandoned, given to humane society. (Animal Shelter, or breed rescue group)

10) The puppy shall under no circumstances be abandoned, given to humane society / Animal Shelter, or breed rescue group.11) Buyer agrees that the Puppy is being purchased for his/her personal ownership and not on behalf of any third party.Furthermore, the Buyer agrees that The Puppy is not being purchased to partake in any illegal activities.

12) The Buyer agrees not to breed with the puppy at any stage without the permission in writing by the Seller. If buyer is in breach of this, will pay the seller an amount of Fifty Thousand Rand (R50 000.00) in addition to what was paid as original price.

13) Any breach of this contract by the Buyer gives the Seller the right to repossess the puppy at the Buyer's expense. Should it become necessary to enforce any part of this contract by legal means, all expenses will be borne by the buyer. No part of this contract is transferable. If any provision of this contract is found by a court to be unenforceable, it shall not affect the validity of the remaining provisions of said contract.

14) All show potential dogs will be sold on co-ownership, the Rion Bullterrier Kennel cannot guarantee a show dog but can identify a potential show puppy. The puppy will be trained and taken to ring craft training by buyer. It will then be assessed by Rion Bullterriers and if deemed fit to show will be entered for shows.

15) All breeding dogs will be sold on co-ownership, terms to be agreed upon in writing.

16) No refunds will be made of any kind to a buyer / potential buyer / applicant of a puppy or adult dog for house pet, show dog or breeding dog.
